



**Terms and Conditions of Use Statement  
For Material Requested From  
The Fred Hutchinson Cancer Research Center  
IHWG Cell and Gene Bank**

**Not-For-Profit/Academic Entity**

By accepting the MATERIAL (as defined below) the RECIPIENT agrees to the following terms and conditions:

RECIPIENT means the institution that requested and is receiving MATERIAL from the Fred Hutchinson Cancer Research Center IHWG Research Cell Bank.

MATERIAL means the Cell Lines (B-LCL) listed in Exhibit 1, attached hereto and incorporated herein in its entirety, and received by RECIPIENT from the Fred Hutchinson Cancer Research Center IHWG Cell and Gene Bank ("FHCRC"), any and all progeny, clones, DNA, including unmodified derivatives of those cell lines and any modifications which are based on or incorporate an element of the original cell line.

The RECIPIENT agrees that it shall use the MATERIAL for biomedical research purposes only. The MATERIAL shall not be sold or used for any commercial purposes. The above MATERIAL is being made available as a service to the research community.

**THIS MATERIAL IS NOT FOR USE IN HUMAN SUBJECTS, INCLUDING FOR PURPOSES OF DIAGNOSTIC TESTING.**

The RECIPIENT agrees to acknowledge the Fred Hutchinson Cancer Research Center IHWG Cell and Gene Bank in any presentations and publications reporting use of the MATERIAL.

The RECIPIENT agrees to use the MATERIAL in compliance with all applicable statutes and regulations

ANY MATERIAL DELIVERED PURSUANT TO THIS AGREEMENT IS UNDERSTOOD TO BE EXPERIMENTAL IN NATURE.
