1. Requesting Organization has obtained institutional approval from either an institutional review board or research oversight committee, to ensure that the Materials received will be used in keeping with the standard ethical practices for research.
2. The Materials received from Fred Hutch will be used only in the performance of the research outlined in section 5 of the order form ("Research Project") and for no other use without the prior written approval of FHCC.
3. The Materials received from Fred Hutch will be used only by Requesting Investigator and those under their direct supervision. Requesting Investigator will not share the Materials with any other investigator(s), within or outside their institution, who are not directly involved in the Research Project, without first obtaining approval from the CCEH Cell Procurement & Processing Core staff/Protocol 985.03 Sample Committee.
4. Requesting Organization will not distribute, sell, or transfer the Materials to any other investigator at their institution or to any third party for any reason without the prior written consent of an authorized representative of Fred Hutch.
5. Requesting Organization will establish and maintain appropriate administrative, technical, and physical safeguards to protect the confidentiality of the Materials and prevent unauthorized use or access to it.
6. Requesting Organization will not use the Materials in any manner in or on human subjects, nor will Requesting Organization use the Materials provided for any diagnostic purpose.
